**Master's Accelerated Program (MAP)**

New Mexico State University master's accelerated program provides the opportunity for academically qualified undergraduate students to begin working on a master's degree during their junior and senior years while completing a bachelor's degree. Typically, a bachelor's degree requires four years to complete, and a master's degree requires an additional two years. The master's accelerated programs allow students the opportunity to complete a graduate program in an accelerated manner. Please talk to your HRTM Faculty Mentor about your MAP plan and develop a course plan in consultation with the advisor.

**MAP Requirements**

The Graduate School allows qualified junior or senior students to substitute its graduate courses for required or elective courses in an undergraduate degree program and subsequently count those same courses toward graduate requirements in a related graduate program.

Undergraduate students may apply for acceptance to the accelerated master's program after completing 60 semester hours of undergraduate coursework, of which a minimum of 25 semester credit hours must be completed at NMSU.

The grade point average must be at least 3.00.

Students must receive a grade of B or higher in this coursework to receive graduate credit. If a grade of B- or lower is earned, it will not count toward the graduate degree.
